PEOPLES FINANCIAL CORPORATION REPORTS RESULTS FOR THE THIRD OUARTER OF 2025

BILOXI, MS (October 22, 2025) - Peoples Financial Corporation (the "Company")(OTCQX Best Market: PFBX), parent of The Peoples Bank (the "Bank"), announced earnings for the third quarter ending September 30, 2025.

Third Quarter Earnings

Net income for the third quarter of 2025 decreased \$14,788,000 to \$643,000 compared to net income of \$15,431,000 for the third quarter of 2024. The earnings per weighted average common share for the third quarter of 2025 were \$0.14 compared to earnings per weighted average common share of \$3.31 for the third quarter of 2024. Per share figures are based on weighted average common shares outstanding of 4,617,466 and 4,661,686 for the third quarters of 2025 and 2024, respectively.

The decrease in net income for the third quarter of 2025 was due to a discrete item of \$15,194,000 recorded as a tax benefit for the reversal of the Company's valuation allowance on federal and state deferred tax assets during the third quarter of 2024. Pre-tax income for the third quarter of 2025 decreased \$548,000 to \$786,000 as compared with \$1,334,000 for the third quarter of 2024. Total interest income decreased by \$920,000 to \$6,910,000 for the third quarter of 2025 as compared with \$7,830,000 for the third quarter of 2024 due to lower interest income on securities and overnight fed funds caused by a decrease in balances and yields offset slightly by an increase in balances and yields on loans. Total interest expense decreased by \$217,000 to \$2,334,000 for the third quarter of 2025 as compared with \$2,551,000 for the third quarter of 2024 due to lower interest rates paid on deposit accounts and borrowings.

Net income for the first nine months of 2025 decreased \$16,980,000 to \$3,195,000 compared to net income of \$20,175,000 for the first nine months of 2024. The earnings per weighted average common share for the first nine months of 2025 were \$0.69 compared to earnings per weighted average common share of \$4.33 for the first nine months of 2024. Per share figures are based on weighted average common shares outstanding of 4,617,466 and 4,661,686 for the first nine months of 2025 and 2024, respectively.

The decrease in net income for the first nine months of 2025 was due to a discrete item of \$15,194,000 recorded as a tax benefit for the reversal of the Company's valuation allowance on federal and state deferred tax assets during the third quarter and first nine months of 2024. Pre-tax income for the first nine months of 2025 decreased \$2,522,000 to \$3,958,000 as compared with \$6,480,000 for the first nine months of 2024. Total interest income decreased by \$3,521,000 to \$21,933,000 for the first nine months of 2025 as compared with \$25,454,000 for the first nine months of 2024 due to lower balances and yields on investments and overnight fed funds offset slightly by higher interest and fees on loans. Total interest expense decreased by \$1,362,000 to \$6,217,000 for the first nine months of 2025 as compared with \$7,579,000 for the first nine months of 2024. This reduction was primarily driven by the loss of several large public fund accounts during the competitive bid process, which resulted in lower interest rates paid on deposit accounts. Additionally, the decrease contributed to reduced interest expense on borrowings.

The Company had a valuation allowance on federal and state deferred tax assets totaling \$15,617,000 as of December 31, 2023. In the third quarter of 2024, the Company reassessed the valuation allowance in accordance with applicable accounting guidance and determined it was appropriate to reverse substantially all the valuation allowance which resulted in a one-time discrete reduction to income tax expense of \$15,194,000 in the third quarter of 2024. Excluding the discrete item, income tax expense for the nine months ended September 30, 2024, totaled \$1,500,000 based upon the expected annual tax rate for 2024 of 23% compared to income tax expense of \$763,000 for the nine months ended September 30, 2025, at an effective rate of 19%.

Return on average assets for the first nine months ended September 30, 2025, decreased 2.79% from 3.33% to 0.54% (the 3.33%, included the discrete item), with the discrete item excluded from the calculation, return on average assets would be 0.82% for the first nine months ended September 30, 2024. The Company's efficiency ratio increased 9% to 81% for the first nine months ended September 30, 2025, compared to 72% for the first nine months ended September 30, 2024.

Asset Quality

"The Bank's leadership remains committed to maintaining high-quality assets. We are closely monitoring economic conditions and staying vigilant for any potential changes in interest rates. As hurricane season continues, the Company has proactively prioritized hurricane preparedness. Across all 18 bank facilities, we have ensured that resources are available allowing branches to operate even in the event of power outages. "The Company has a comprehensive and thorough business continuity and disaster recovery strategy." said Chevis C. Swetman, chairman and chief executive officer of the Company and the Bank.

Shareholders' Equity

Total shareholders' equity increased by \$10,008,000 from \$90,001,000 at December 31, 2024, to \$100,009,000 at September 30, 2025. The improvement in shareholders' equity was partially due to the nine-month earnings of \$3,195,000 through September 30, 2025. The Company also experienced a decrease of \$7,644,000 in unrealized losses on securities in 2025. The Company reported \$30,362,000 and \$38,006,000 in unrealized losses on the available for sale securities portfolio as of September 30, 2025, and December 31, 2024, respectively. These unrealized losses are presented in accumulated other comprehensive income for the respective periods. The cause of the unrealized losses has primarily resulted from higher interest rates that have impacted the current market value of available for sale securities. The unrealized losses are not related to any credit deterioration within the portfolio. The Company has maintained strong liquidity and continues to do so; therefore, the Company does not foresee a sale of any affected securities that would cause the realization of these losses by the Company as part of net income in the near future.

The Bank's leverage ratio has not been impacted by these unrealized losses on available for sale securities due to an optout election previously made by the Bank in accordance with current regulatory capital requirements and therefore remained strong at 15.19% as of September 30, 2025.

Liquidity

The Company maintains a well-capitalized balance sheet which includes strong capital and liquidity. The Bank provides a full range of banking, financial and trust services in our local markets. The majority of the Bank's deposits are fully FDIC insured. The Company evaluates on an ongoing and continuous basis its financial health by preparing for various moderate to severe economic scenarios.

As interest rates have increased and the cost of attracting new deposits and replacing deposit attrition has increased, the Bank experienced a decrease in deposit balances during the nine months ended September 30, 2025. This decrease was mostly caused by the loss of several large public fund deposits in 2025 following competitive bid processes held in 2025 whereby the public fund deposit accounts were awarded to other local banks. As of September 30, 2025, total deposits have decreased \$83,154,000 to \$637,576,000 from \$720,730,000 as of December 31, 2024.
